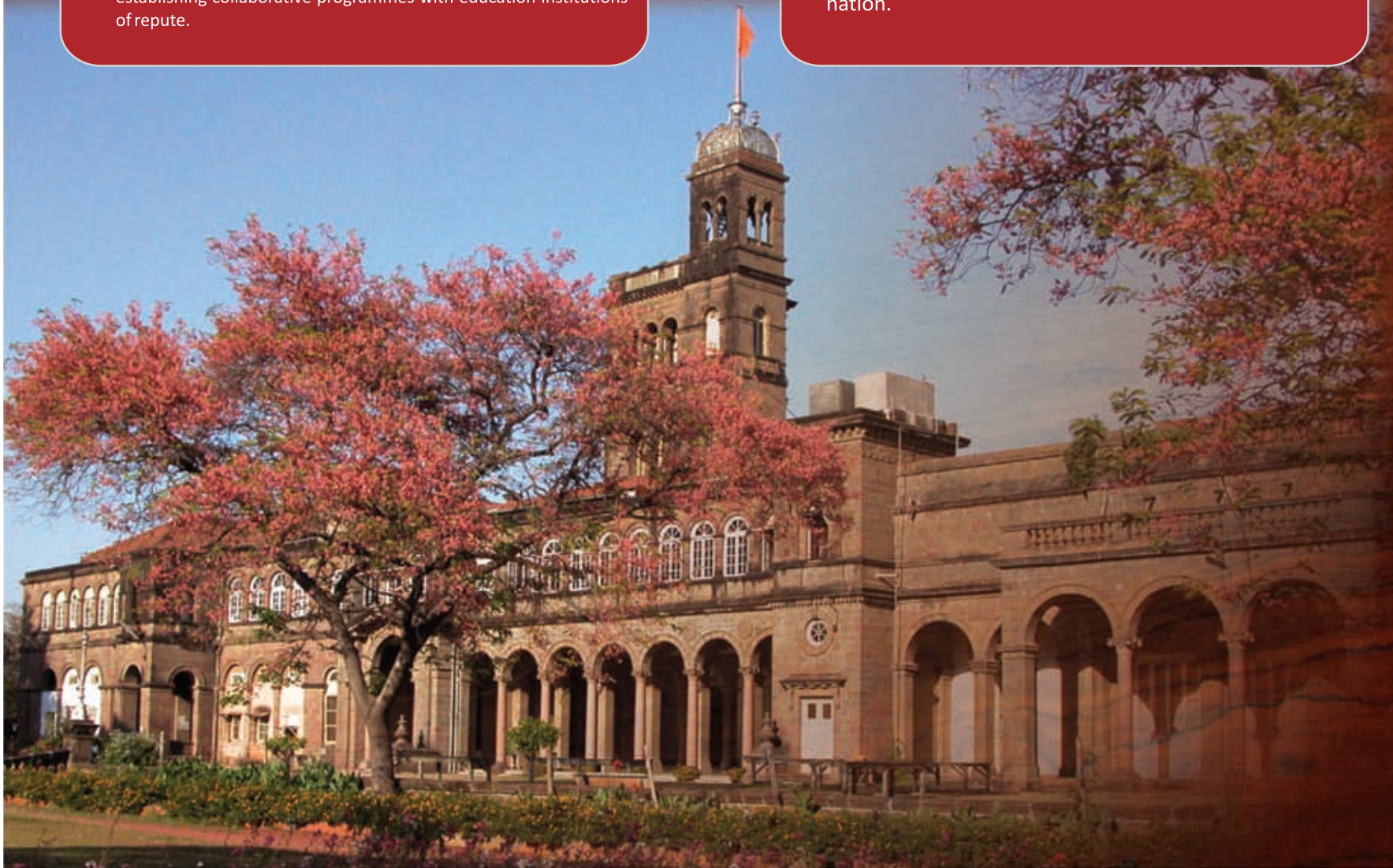

Recruitment

The Department of Law has its own Placement Cell which exclusively looks after the recruitment process. Faculty in-charge of Placement Cell is Ms. Sonia Nagarale (Asst. Professor, Dept. Of Law, University of Pune) who is assisted by a group of student volunteers for the placement activity.

Recruitment Process:-

The Placement Cell follows a three stage recruitment process.

1st Stage

The potential recruiters have to inform the Placement Cell about their willingness to participate in the placement programme, by providing the requisite information in the 'response sheet' and sending it to the Placement Cell via e-mail and facsimile.

2nd Stage

The potential recruiters may conduct pre-interview rounds like written test, group discussions, pre-placement talks prior to the final interview round. The potential recruiters will have to coordinate with the Placement Cell to decide upon convenient date and time to conduct the same.

The names of the students selected for the final interview should be provided by the potential recruiters to the Placement Cell.

3rd Stage

The Placement Cell will confirm to the potential recruiters the dates of the placement week during which the potential recruiters shall conduct the final interviews.

The potential recruiters shall inform the names of the selected candidate/s to Placement Cell immediately after the final interview and make available the copy of placement offer letter at the earliest.

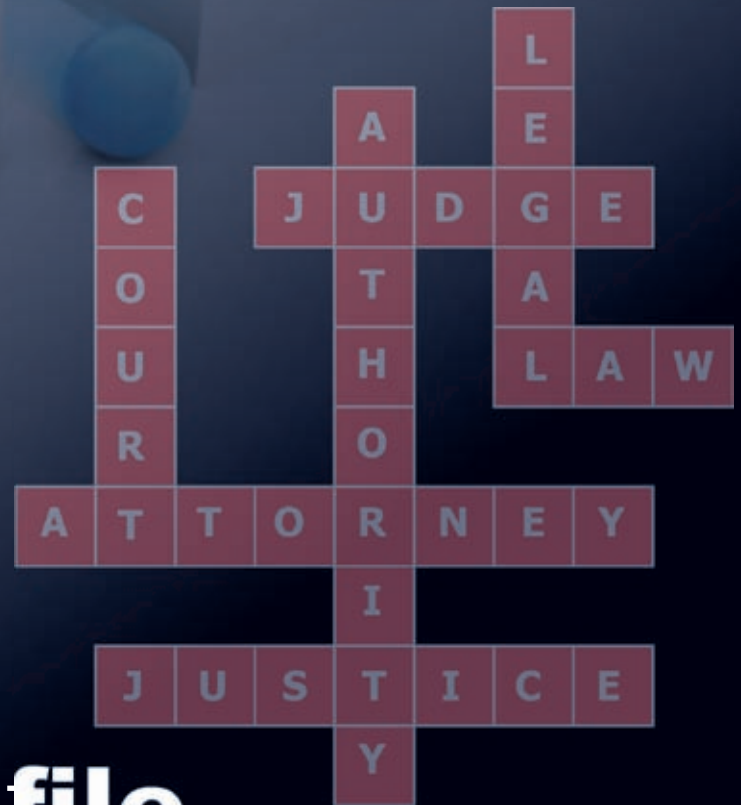
The Placement Cell would communicate the acceptance of the placement offer.

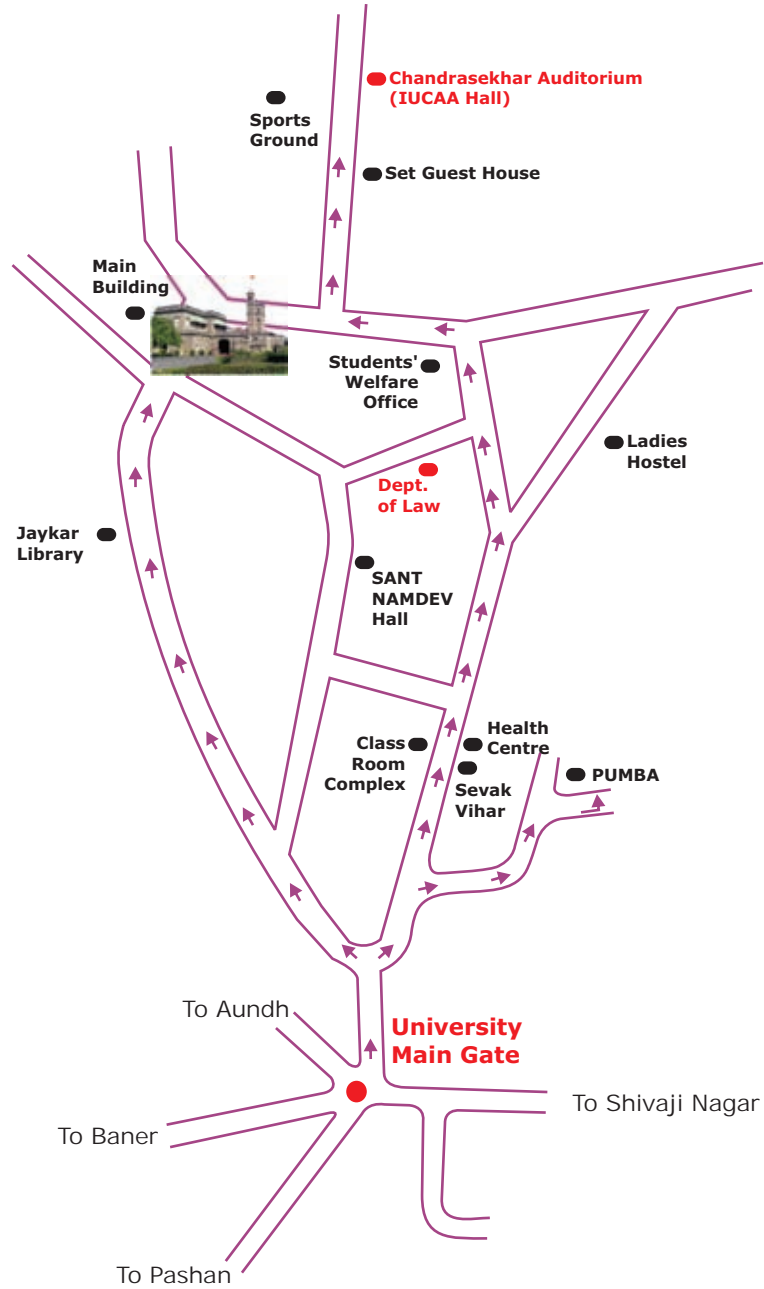
