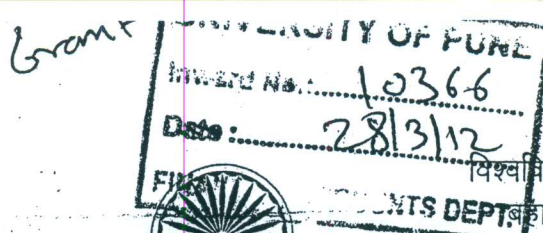

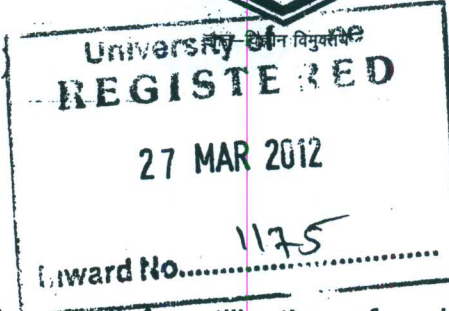

Sub.: Extension of time limit for utilization of various component of General Development Assistance Scheme and other plan grants including Merged Schemes during XI plan period.

Sir,

As per the Commission decision in its meeting held on 13.02.2012 the issue regarding granting of extension beyond 31st March, 2012 for utilization of various components of UGC XI plan Development grant and other plan grants including Merged schemes to State Universities was considered as under:

"The Commission considered the issue of granting extension beyond 31st March, 2012 for utilization of various components of UGC XI plan Development Grant and other plan grants including Merged Schemes to State/Central/Deemed Universities and Colleges and decided that two years Extension upto 31-3-2014 may be given for completion of buildings where building construction has started on or before 31-3-2012. Extension upto 31-9-2012 was approved for incurring expenditure on other items, excluding faculty positions"

In view of the above extension in period of utilization of XI plan Development grants and other plan grants including Merged Schemes is being granted as per details given below:-

S.No.	Items	Period
1	Faculty position	No extension beyond 31-3-2012 is granted. Expenditure on staff salary will be admitted only upto 31-3-2012.
2	Buildings	Two years extension upto 31-3-2014 has been given for completion of buildings where construction work has been started on or before 31-3-2012.
3	Items other than staff and Building	Extension has been granted upto 30-9-2012 for utilization for funds.

The Universities are requested to submit the statements of expenditure and audited Utilisation Certificates for the period mentioned above in respect of plan grants received by them under various schemes including General Development Assistance Scheme and Merged Schemes during XI plan period.
