In terms of section 14 of the NCTE Act, 1993, the UNIVERSITY OF PUNE had submitted an application (Code No. APW08120/125250) to the RC for grant of recognition for conducting M.ED. (E)(CO-ED) course of 1 year duration with an annual intake of 25 students at DEPARTMENT OF EDUCATION AND EXTENSION, UNIVERSITY OF PUNE, PLOT NO. 25, S.NO.25, KHASRA NO. 1/1/1/PL/1/1A/1, VILL. AUNDH, DIST. PUNE, MAHARASHTRA.

2. On the basis of scrutiny of the document submitted by the institution, the documents attached therewith, input received from the Visiting Team Report and videography along with related documents. The WRC in its 122 meeting held on July 20-21, 2009, is satisfied that the above institution has adequate financial resources, accommodation, library, laboratory as prescribed in the norms and standards and that it fulfills all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course.

3. Before grant of formal recognition under Regulation 7(11) is considered, you are requested to submit the following:-

- (i) The institution shall make appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An Affidavit on the enclosed format on Rs.100/- Non-Judicial stamp paper by the Applicant is required to be submitted along with individual affidavits (on another enclosed format) to be submitted by the academic staff duly selected and appointed.

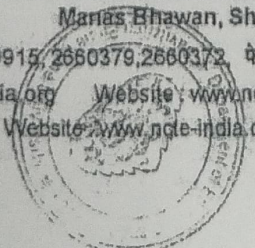

(ii) The institution shall launch its own website covering *inter-alia*. The details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, classrooms and other facilities/amenities), instructional facilities (laboratory, library etc.) and the particulars of their proposed teaching and non-teaching staff etc. with photographs. The details of the website may be submitted.

(iii) As per provision of clause 8(7) of NCTE Regulation, 2007, the land has to be in the name of institution it self. Therefore, as per above provision and instruction contained in letter No. 48-3(11)/2008/NCTE (N&S) date 13.03.2009, issued by NCTE HQ, you are directed to convert the land in the name of the institution i.e. DEPARTMENT OF EDUCATION AND EXTENSION, UNIVERSITY OF PUNE on ownership basis within 3 (three) months and submit the documentary proof/evidence in this regard to the office of WRC.

- 4. Admission should not be made until formal recognition order under Para 7(11) of the NCTE (Recognition Norms & Procedure) Regulations, 2007 is issued by the Western Regional Committee, NCTE and affiliation is obtained from the University/examining body concerned.
- 5. You are advised to comply the above requirement before formal recognition is considered under Regulation 7(11).

Public Notice

Sub:- Enhancement in the intake of M.Ed. programme from 25 seats to 35 seats-reg.

As per National Council for Teacher Education, (Recognition Norms & Procedure) Second Amendment Regulation 2010, published in the gazette of India on 26.07.2010. In paragraph 3, in sub-paragraph 1, in clause (a), in appendix-5 of NCTE Regulation, 2009, for the words 'twenty five students', the words 'thirty five students' shall substituted.

In this regard as per the letter No. F.No. 49-4/2010/PT/NCTE(N&S) dated 30.07.2010 issued by NCTE, New Delhi, the above amendments stipulates that the intake be increased from existing 25 to 35 students from the current session 2010-11 in the M.Ed. course without creation of any additional infrastructure and instructional facilities. The all institutions in the Region of WRC having approved M.Ed. program of 25 students from WRC, NCTE, Bhopal may enhance it upto 35 students accordingly.

A separate letter to all such institutions is being issued separately.

Revised Order

Whereas, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the DEPARTMENT OF EDUCATION AND EXTENSION, UNIVERSITY OF PUNE, PLOT NO.25, KHASRA NO. 1/1/1/PL/1/1A/1, VILL. AUNDH, DIST. PUNE, MAHARASHTRA by affidavit dt. 13.01.2015 has consented to come under new Regulations and sought for One Basic unit of 50 students in M.Ed. Course of two years duration which require additional facilities.

3. ~~As per the request it has been decided to permit the institution to have one basic unit of 50 students, subject to the condition of fulfilling the following conditions before 31.10.2015.~~

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing Institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the Institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such Institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to DEPARTMENT OF EDUCATION AND EXTENSION, UNIVERSITY OF PUNE, PLOT NO.25, KHASRA NO. 1/1/1/PL/1/1A/1, VILL. AUNDH, DIST. PUNE, MAHARASHTRA for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic units of 50 students) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned Institution before grant of affiliation to an Institution.
