Admission guidelines for the academic session 2020-2021

A) Guidelines for Students for Admission in DBT supported PG Courses:

- (1) After declaration of Result of GAT-B 2020, candidate will download the rank card/score card from RCB Faridabad website: https://rcb.res.in
- (2) The RCB website will also display the name of participating universities/institutes and courses being offered under DBT support and respective eligibility conditions. (weblink: https://rcb.res.in).
- (3) The rank card/score card holder will visit the concerned university's/institute's website for re-confirmation of eligibility conditions of admission.
- (4) Eligible candidates will have to fill application form of individual University/Institute as per their guidelines.
- (5) After display of admission list by concerned University/Institute, students will contact the respective Program Coordinator of DBT supported PG Course for seeking admission and completing the required formalities.
- (6) The issuance of Rank/ Score Card does not guarantee admission in DBT supported PG Teaching Courses. Confirmation of admission under DBT supported course is subject to fulfillment of required eligibility conditions/criteria set by concerned Universities/Institutes. Department of Biotechnology, GOI does not have any role and responsibility in admission process after declaration of GAT-B Result.
- (7) Any further update/information about admission process will be displayed on DBT website (dbtindia.gov.in/) and RCB website (rcb.res.in).

(B) Guidelines for participating Universities/Institutes for admission under DBT supported PG Courses:

- (1) The concerned Universities/Institutes will display the eligibility criteria for admission, number of seats, reservation as per GOI norms for DBT supported PG Teaching Course at their website and notice/advertisement for admission.
- (2) The concerned Universities/Institutes may decide admission criteria as per Institutional norms and display the list of selected candidates for admission along with a waiting list.
- (3) The concerned Universities/Institutes should not charge any application fee from applicants (GAT-B Rank/Score Card Holder). The fee may be collected from the admitted students at a later time point along with tuition fees.
- (4) Universities/Institutes may allow transfer of candidate once in 2020-21 academic session and refund of fees as per UGC norms.
- (5) The concerned Universities/Institutes should follow the timelines and schedule as given in Annexure I for admission in 2020-21 academic session under DBT supported PG Courses
