# II. Major Developments in the Department

- (1) Academic activities and programmes of the Department received a major fillip through the University Leadership Programme sanctioned to the Department by the University Grants Commission. A major step forward is taken by the Department by identifying Sociology of Development as the thrust area. It is now planned to orient teaching, research, seminars, workshops and other academic programmes of the Department to the field of sociology of Development.
- (2) Professor Y. B. Damle, M. A. Ph. D. (Bombay), who was on the faculty of the Department as Professor and Head, retired on 30th April 1983. In recognition of his scholarship and pioneering contribution to the development of the Department, the authorities of the University of Poona have appointed him as Professor Emeritus of Sociology in the Department. The Government of Maharashtra has honoured Dr. Damle by conferring the State Award for the Best Teacher on 26th January 1983.
- (3) A National Seminar on "Theory and Concept in Indian Sociology" was organised by the Department in February-March 1983 with the financial assistance of ICSSR. Twenty five Indian and foreign scholars participated in the seminar and in all 15 papers were presented. Prof. D. N. Dhanagare was the convenor of this Seminar.
- (4) The University has recently appointed Prof. T. N. Valunjkar as Professor of Sociology, and Dr. (Mrs.) Anuradha U. Bhoite Reader in Sociology, in the Department in 1983. Their bio-data are given in the Appendix.

# X. The University Leadership Programme in Sociology

The University Leadership Programme in Sociology, which was formally launched by the Department in June 1978, has acquired considerable momentum. Under this programme the faculty members of the Department are contributing to the improvement of the teaching of Sociology at the under-graduate level in Colleges affiliated to the University of Poona in three ways:

- (a) Teaching at the Under-Graduate Level,
- (b) Training and reorientation of the under-graduate sociology teachers, and
- (c) Preparation of reading materials so as to attend to the special needs of the revised courses and syllabi.
- (a) Teaching at the Under-Graduate Level:

The faculty members of the Department delivered 'model' lectures at the undergraduate level in Colleges affiliated to the University of Poona. Teachers of affiliated Colleges suggested topics from the syllabi they taught, on which they wished to arrange 'model' lectures by the faculty members of the Department. Besides Colleges in Pune, the faculty members delivered lectures under this scheme in Colleges in Nasik, Dhule, Jalgaon, Ahmednagar, and Baramati on topics of interest to undergraduate students there.

- (b) Training and Re-orientation of the under-graduate Sociology Teachers:

  The Department organized one Workshop and one Winter-Institute aimed at the above academic goals:
  - (i) Workshop for the College Teachers (November 24-29, 1980):

As a part of the U.L.P. programme a workshop covering various fields of sociology, such as, Sociology of Religion, Political Sociology, Rural Society and Reconstruction, and Social Movements was organized. Besides faculty members, eminent experts representing different academic disciplines and social activists, namely, Dr. Anil Avachat, Shri Vasant Palshikar, Shri Sayyad Bhai, Dr. C. R. Modak, and Shri Jagdish Godbole, delivered stimulating talks relating to the above fields. More than 30 college teachers teaching Sociology in various Colleges affiliated to the University of Poona, took part in the workshop.

(ii) The U.G.C. Winter Institute on "Society and Culture in Maharashtra (2nd November to 30th November, 1981).

A Winter Institute on 'Society and Culture In Maharashtra' was organized by the Department, from 2nd November to 30th Nobember 1981. Various aspects of Maharashtra society such as historical, economic, socio-cultural, educational, and political were covered in the discussions, lectures, and symposia. Problems of development and social transformation was the main focus of the Institute. In addition to the contribution by the faculty of the Department, renowned authorities on Maharashtra like Prof. G. B. Sardar, Prof. V. M. Dandekar, Shri Prabhakar Padhye, Prof. Nalini Pandit, Shri Shankarrao Kharat, Shri S. M. Joshi, Shri N. G. Gord Prof. Gangadhar Gadgil, Shri Pantawane, Dr. Gail Omvedt, Tarkateertha Laxmanshastri Joshi, Mrs. Vidya Bal, Dr. M. V. Patwardhan, Chairman, Bank of Maharashtra, and several others gave the benefit of their expertise to the participants. The Institute was inaugurated by Shri Lakshmanshastri Joshi with a keynote address on 2nd November1981, and Prof. Ram Joshi, Vice-Chancellor, Bombay University delivered the valedictory address.

# (c) Preparation of New Reading Material:

Dr. (Mrs.) A, Ramanamma, faculty member of the Department, prepared a book on Social Demography in collaboration with Dr. M. K.
