The new executive started functionin; from Dec 21, 1985. We present below a brief account of our organisation and its activities since then. Details of some of our activities are given in the appendix.

courts, publication of reports and organising meetings are as follows:

1. Andhra

Repression on peasants, tribals, and civil rights activists has continued unabated this year. Dr. Varavara Rao, noted poet, was compelled to cancel his bail and go to jail due to intensified threats to his life. We issued a press statement asking the Andhra government to ensure the safety of Dr. Varavara Rao and others and also sent a telegram to the Chief Minister (Jan.) In Feb. we submitted affidavits attesting to Dr. Balagopal's presence in Delhi during the period of his visit here, when, according to police charges, he was allegedly involved in conspiratorial activities in Andhra. Dr. Balagopal was subsequently released on bail. On Sept. 3 we observed Civil Rights Day in memory of Dr. Ramanatham, killed by police last year and published "In Defence of Civil Rights" to honour his contribution to the democratic movement. Tragically, only two months later, Nov. 7.1986, APCLC leader J. LAXMA REDDY was shot dead by the police in his house in Karimnagar. We brought out a pemphlet on the killing. We also wrote a rejoinder to the letter by Telugu Decam leader P. Upendra in the 'Times of India. We pointed out that he had misrepresented facts and that not only had the NTR government not ordered judicial enquiries into the killings of APCLC leaders Dr. Ramanatham and Laxma Reddy, but that the journalist from "Andhra Jyoti" who had reported Reddy's killing was being harassed by the police. As to the courts, we wish to point out that the supreme Court dismissed the pettition on encounter killings and directed that a private complaint be filed.

Various cases were launched a sainst activists working for the victims of the gas tragedy in Bhopal by the M.P. government. We obtained a stay on the cases against Dr. Anil Sadgopal and 20 others in tituted in 1985. We withdraw from the Delhi Committee on the Bhopal Gas Traged; formed in the wake of the arrests of activists as the context in which it was formed was no longer operative. In Sept. this year volunteers of the Bhopal Group for Information and Betion (BGIA) faced arrest and false charges under the Official Secrets Act. Nandita Hakser was in a team whi met the Chief Minister in Bhopal for the release of BGIA voluntee We conducted two meetings on this issue and are giving legal help for petition in Supreme Court for the right to information and free speech.

3. Wihar

we visited three districts in May after the arwal killings to invastigate the causes of rural killings in Bihar. We published a report "Behind the Killings in Bihar" and filed a case on the Arwal killings in the supreme Court. Acceding to one of our prayers that all victims, and not only Harijans as announced by the government, be given compensation, the court directed in December that families of the killed by p id &s. 20,000/- each and the injured &s. 5,000/- each. In August we cyclostyled a brief report on the ban on MKGS and the repression on various organisations participating in the Vidhan Sabha gherao in protest against the Arwal killings. Dr. Ashwini Ray addressed a meeting on Arwal organised by the Delhi Committee and Mr. Mukhoty addressed another meeting at Boat Club.

4. Delhi.

We participated in various meetings and marches for communal harmony and investigated the condition of migrants from Punjab, as well as visited riot affected areas in West Delhi and Jama Masjid. We also investigated the illegal lockout affecting 140 workers of Sigma Rubber Corporation. We investigated a case of torture at Rajinder Nagar police thana and we petitioned the Supreme Court concerning death in police custody of an alleged Sikh terrorist at the Ashok Vihar Thana. Our petition was dismissed and the court directed us to file a private compl int. In one case of a young boy picked

up on suspicion of theft and illegally detained at the Greater Reilash - I thana, we were able to intervene effectively and prevent further torture.

5. Orissa

We sent a fact-finding team to investigate the impact of bauxite mining in the Gandharmardhan area in June. Later, with the help the journal MAIN STREAM, we published the report in November. The report was delayed due to the illness of our members.

6. Punjab.

In addition to press statements condemning killings at Muktasar and the take over of the Golden Temple by the AISSF, wa organised a meeting addressed by Dr. Sucha Singh Gill (Patiala) and Dr. Sandhu.

7. Women

on behalf of Stree Shekti Sangathan. The case was of rape by policemen of a woman in a village in Karimnager in Andhra. The petition was dismissed. We also published an updated second edition of our booklet on women, "Inside the Family". We need another reprint as our stock is exhausted and there is continuing demand for this booklet.

8. Journalists

We issued press statements on the harassment of the editors of "Peeng" and "Nai Danuiya". The editor of "Peeng" had been arrested and illegally detained for three weeks for exposing corruption of the Bhajan Lal government. The government was admonished by the Press Council of India (PCI) for the linest. The editor of "Nai Duniya" was arrested and kept two weeks in Tihar Jail. He was charged under the Anti-Terrorist Act for having published two years ago an interview with Khalistan supporter, Jagjit Singh Chauhan. We also provided legal help. In addition, we protested against the harassment by police of a reporter of "Andhra Jyoti",

FCDR lowyer is appointed in a unique case on behalf of four journalists who have filed a complaint to the PCI concerning the co-munal bias of an editorial of Times of India.

9. Convention

Having been fixed in recent years with rising communalism in Delhi and other parts of the country, we organised our fifth annual convention on the theme of "Relgion, State and Democratic Rights." It was held on 6, December and was well attended. The first session included well-known historians and the second session included well-known activists. In the evening we screened a film on communal riots in Hyderabad, "Kya Hua Ees Saher Ko."

10. Legal

We undertook at least 13 new cases this year, including two in the Press Council. Both the new cases and the large number pending from past years relate to a variety of issues concerning the rights of peasants, workers, fishermen, tribals, bonded labour jain fetenus, children, and other sections of our people.

R.N. Mishra Commission.

PUDR-PUCL petition to be impleaded as parties to the commission was dismissed in Jan as we were not called to give evidence despite the f ct that we had submitted joint report "Who are the Guilty?" as affidavit. Our lawyer however appeared on behalf of Magrik Ekta Manch (NEM). The citizens Justice Committee and NEM withdrew later in protest from the commission. Its report has been finalized but has not yet been made public.

12. Fraternal

We highlighted the attacks on civil rights activists in andhra, Chandrapur and Karnataka and gave legal assistance where possible. In addition, we participated in a conference on communalism organised by CPDR (Bombay), on dams and the communalism (Chandrapur), and another on communalism

organised by CPDR (Nampar) has also participated in conventions organised by the SPDR (Calcula) and the NPHMR in Delhi. We have given several joint statements with PUCL and participated in its programmes.

13. Other organisations

taken up by various joint fronts and organisations. These included the issue of arrests of 90 Nepali students and the violation of human rights of Tamils in Sri Lanka. Mr. Mulhety has addressed several meetings, including Human Rights Convention held at Aligarh.

14. Organisation

We held six executive meetings this year, some thinly ettended. Two members Ms. Tonuca Bhowmik and Dr. A.Ray (one of our secretaries) have left Delhi for academic work. We were unable to implement the decision to have an executive meeting every month. We were also unable to implement the decision to publish a commemorative volume on democratic rights in honour of Dr. Ramanatham. We have got only four articles so far for the volume.

Our weekly activists meetings continue. Although new activists have joined, we need strengthening of the activist group as a number of activists, due to new responsibilities at home at work, are not able to give as much time as they did previously.

15. Finance

The annual turnover for 1986 was Rs. 17,028.26. This was lower than last years as total amont of printing this year was less. Printing accounted for 37% (Rs. 6,303) of the total turnover. Since we did not publish the convention

papers, dyclostyling costs accounted for only 3.9% (Rs. 671/-). Legal costs incurred were 5.1% (Rs. 765/- excluding a large amount done free of cost by our lawyers). Hell booking, projector, mike expenses were 6% (Rs. 870.50). Other expenditures were on justage, stationery, etc. and a small donation to the Delhi Committee on Bhopal Gas Tragedy.

As for resources, a large amount Rs. 5,000/- was given by the Supreme Court as reimbursement for expenditure incurred for some of our earlier cases. Sales were poor and accounted for only 10% (Rs. 1,178/-) while donations accounted for 15.7% (Rs. 2,667/- Sixty percent of donations were through monthly donations by members. Membership accounted for Rs. 150/- and bank interest amounted to Rs. 250.29.

The opening belance on Dec, 21.1985 was Rs. 7,242.97 and the closing balance on December 20, 1986 is Rs. 7,459.76.

This year also various forms of harrasment of civil liberties movement continued in the country. Activists in Karnataka, Maharashtra and Andhra and journalists from different parts including Delhi faced repression. But for us this year is a relatively less tense year. Organisationally, our strength; is considerably depleted and presently there is an immediate need for expansion. Facing the increasing threat to our movement while building the strength of the organisation remains the difficult and challenging task for the coming year.

- 1. PUDR vs. State of Bihar. W.P. (Crl. no. 369, 1986)

 Petition filed on behalf of victims of illegal police firing at Arwal on April 19, 1986. The court has acceded to one of the prayers, namely, that payment of compensation should not be confined to the Harijan victims as announced by the government. On December 19, the court directed that compensation of Rs. 20,000/- each be paid to the families of all the victims killed and Rs. 5,000/- each to the injured.
- PUDR vs. Commissioner of Police (Delhi) WP (Crl. no: 101, 1986)
 Petition concerning police custody death of Dalject Singh, Ashok Vihar Police thana. Despite overwhelming evidence of torture, the SC threw out the petition and asked PUDR to file a private complaint.
- *3. Mineral and Magnesite vs. H.S. Karki. SLP no. 2324, 1986.

 Case of a Worker who organised the first union among magnesite miners in Pithoragarh dist., U.P. in 1979. He was thrown out of his job a few months later and and filed a case. He was an activists of the Uttarakhand Sangarsh Vahini. He suddenly died a few months ago leaving behind a young widow and three small boys. The case was won in the High Court, but an appeal was filed in the SC, which is pending. The arrears of his wages have been already deposited in court.

PUDR lawyer is appearing on behalf of four journalists who have filed a complant with the PCI about the communal bias in Mr. Girilal Jani's editorial Nov. 2, 1984, Times of India. It is the first case in which linguistic evidence was heard.

- PUDR lawyer assisted editor of "Peeng" in his case against the Haryana government. The editor had been arrested and suffered three weeks illegal detention because of his exposure of the corrupt practices of the Bhajan Lal Government. The Haryana government was admonished by the PCI for the arrest.

Petition by journalist focussing attention on the plight of juveniless in children's homes.

Petition seeks to link the right to information with the fundamental right to freedom of speech and expression. The volunteers have been charged with spying, under the Official Secrets Act.

Petition linking right to information with freedom of expression. More than 20 activists and gas victims have been implicated in numerous cases in the course of the last two years. The court has ordered a stay on all the cases.

- 13. Susie Theuru vs. State of AP.

 WP (Crl) no: 512, 1985

 Petition on behalf of Stree Shakti Songethan concerning rape of a woman by policemen in a village in andhra. The victim had indentified the policemen involved, but later withdrew her complaint due to severe harassment of her family. The SC dismissed the petition despite the fact that the victim had categorically named the involved policemen several times.
- 14. APCLC vs. State of A.P. WP.(Crl) No: 1258, 1985.

 PUDR lawyers had asked for magisterial enquiries on encounter deaths. The enquiries were produced in court but the state claimed privilege. Before we could argue privilege, the SC dismissed the petition and told us to file a private complaint.
- 15. Munnuswamy vs. State of Tamilnadu, 1985.

 Petition concerning 10,000 fishermen, deprived of their livehood in the wake of beautification drive of Marine Beach, Madras. Court has appointed Commission consisting of representatives of fishermen and the government to solve the problem. Last

year it had directed that all the confiscated catamarans and boats be returned and the fishermen allowed to continue fishing from Marine beach.

16 Puli Srinivasulau vs. State of AP. WP (Crl) No: 1132, 1985

Political Prisoner detained for 18 years has been released and the case has been disposed off.

 Contempt petition in SC because orders of SC not implemented. The case involves transfer of 318 workers because they had formed a union.

A batch of writ petitions concerning 93 bonded labourers. Some of them have been rehabitated and the sub-collector himself has has brought out a list of 480 other bonded labourers who have been rehabititated.
