Rules of A.T.K.T.

- (c) While appearing Third Year examination students should have passed First Year Examination i.e. Backlog of First year Examination are not allowed while appearing Third Year Examination.

- 1. Candidate must select the Subjects which he/she had studied at F.Y.B.COM.
