Rules of A.T.K.T.

- (a) Students who have Backlogs of Two Theory Papers and one Practical paper of First Year can appear for Second Year Examination.
- (b) Students who have Backlogs of Two Theory and one Practical paper of Second Year can appear for Third Year Examination.
- (c) While appearing Third Year examination students should have passed First Year Examination i.e. Backlog of First year Examination are not allowed while appearing Third Year Examination.

Candidate is required to confirm that he/she has (✓) ticked against those subjects (Theory & Practical separately) for which he/she desires to appear:

1. Candidate must select the Subjects which he/she had studied at F.Y.B.COM.
2. Candidate must select the Subjects which he/she had studied at F.Y. & S.Y.B.COM.
3. Candidate must select the Subjects which he/she had studied at T.Y.B.COM.

Backlog students of S.Y.B.Com. 2004 pattern will have to appear as per equivalent Subject to 2008 Pattern.
