Appointment of Controller of Examinations

Applications are invited in the prescribed form for the post of **Controller of Examinations** of the University of Pune.

Qualification:

- (i) A Master's Degree with at least 55% of the marks or its equivalent grade of B in the UGC 7 point scale.
- (ii) At least 15 years experience as Lecturer (Senior scale)/Lecturer with 8 years experience in Reader's Grade along with experience in Educational Administration

OR

Comparable experience in Research establishment and/or other Institutions of Higher Education.

OR

15 years Administrative experience of which 8 years as Deputy Registrar or equivalent post. (as per Government Resolution dated 05/01/2002)

(iii) Relaxation from 55% to 50% may be given only to those candidates who belong to teaching or SC/ST categories or who have obtained Ph.D. Degree and passed Master Degree prior to 19th September, 1991 or those existing incumbents who are already in the University system.

The candidate should have proficiency in Marathi, Hindi and English languages.

The post of Controller of Examinations is an isolated post.

Age : Unless already in the services of Universities or affiliated colleges/ recognized institutions of the University of Pune, not less than 45 years of age.

Tenure: This is a tenure appointment for a term of five years and the person shall be eligible for reappointment for only one more term of five years.

- **Pay Band:** Pay Band Rs.37400-67000+A.G.P. 10,000/- with usual allowances as per Government Rules. [Minimum pay in Pay Band Rs.43000/-]
- **Retirement Age:** Shall be 58 years. However, in the case of a person from teaching cadre, the age of retirement shall be 60 years.

The post carries the retirement benefits as per the Government/ University Rules.

- 2. Application form should be accompanied with attested copies of the necessary documents and the certificates, a Pass port size photo, Demand Draft of Rs.300 /- for open candidates (Reserved category candidates Rs.150/-) of nationalized bank drawn in favour of the "Registrar, University of Pune" payable at Pune.
- 3. Candidates shall submit the printed copy of the application form along with all enclosures to Deputy Registrar, Administration Non-Teaching Section, University of Pune, Pune 411 007 on or before 12/04/2012.
- 4. As per the Notification No.SRV.2000/CR (17/2000) XII dated 28th March, 2005 issued by General Administration Department, Mantralaya, Mumbai, Candidates shall submit the declaration of the small family in the prescribed proforma attached with Application form as Declaration form "A"
- 5. Qualifications, relevant experience and age shall be considered as on last date of receipt of application.
- 6. Candidates furnishing incorrect or false information shall stand disqualified at any stage.
- 7. The University reserves the right to fill or not to fill the post or to modify/ alter/ cancel the advertisement.
- 8. A Candidate already employed, shall submit his/her application through proper channel.
- 9. Applications received after the last date of receipt of application, incomplete applications and applications not submitted through proper channel will not be considered, and no intimation in this regard will be given to the candidates.
- 10. Canvassing directly or indirectly will be a disqualification.
